**ANNOUNCEMENT
Expression of Interest for the admission of Postgraduate Students
for the academic year 2025-2026**

The Department of Early Childhood Education of the School of Education, the Department of Medicine and the Department of Biological Applications and Technologies of the School of Health Sciences of the University of Ioannina organize and implement the Interdepartmental Program of Postgraduate Studies from the academic year 2018-2019. This program has been updated, from the academic year 2025-2026, entitled, «**Environmental, Health and Educational Sciences: Education for Sustainability**», and leads to the acquisition of a Master's Degree in "Environmental, Health and Educational Sciences: Education for Sustainability".

20 Masters Students are admitted to the Master's Program, as shown below:

1. Holders of first cycle of a Higher Education Institute in Greece and
2. Holders of first-cycle degrees from foreign institutions that have been recognized by the Hellenic National Academic Recognition and Information Center (D.O.A.T.A.P.), in accordance with the provisions of paragraph 4 of article 304 of the law 4957/2022 (A' 141) and wherever this is required.
3. Holders of first-cycle degree of the cooperating foreign Institutions with which a cooperation protocol has been signed.
4. Members of the teaching staff of the University (E.E.P., E.D.I.P. and ETEP) are accepted in addition, only one per year and per Post Graduate Program which is relevant to the degree and the work they perform at the relevant Institution, provided they meet the admission requirements and the selection criteria.

The selection of Postgraduate Students is made according to the following criteria:

2. Competence in a second or other foreign language (1 credit per language)	4 (max.)
3. Oral examination – Presentation	25 (max.)

5. Overall grade of first cycle degree (from 5.00- 6.49 "good": 1 point, from 6.50- 8.49 "very good": 3 points, from 8.50- 10.00 "excellent": 5 points)	5 (max.)

9. Scientific publications in scientific journals (priority in English) and conference proceedings (international priority).	5 (max.)

Teaching in the Interdepartmental Program of Postgraduate Studies is conducted distantly (up to 70%) and face to face (at least 30%) and the tuition fees are €3,000.

The Interdepartmental Program also offers an elective course in One Health Education (One Health Education Study Abroad program), which grants an additional 6 ECTS through a certificate. The course is conducted at the University of Ioannina in collaboration with important American universities (George Mason University and University of Florida).

Applicants are invited to submit **until October 15, 2025** to the Secretary of the Department of Early Childhood Education, a nomination file with the necessary supporting documents, **by e-mail** to the Secretary's email, gramptn@uoi.gr:

1. Application form (available in the website of the Department: <http://ecedu.uoi.gr/>),
2. Copy of Degree and other Titles (Certificate of recognition of degree equivalence by D.O.A.T.A.P. for foreign graduates),
3. Record of study of the undergraduate courses,
4. Proof of knowledge of a Foreign Language/Languages (C1 level at least, if available),
5. Curriculum vitae,
6. Any other document that may contribute to the CV of the applicants (e.g. letters of recommendation, thesis, publications, research experience, professional experience, etc.).

Candidates will be called to participate in an **oral examination – presentation** by a competent Commission.

It is absolutely necessary for candidates to obtain a total of at least thirty (30) points in the written exam of comprehension of a scientific text in a foreign language and in the oral exam - presentation.

The exact dates will be announced after the completion of the application process of the written exam of comprehension of a scientific text in a foreign language. Finally, those who pass the written exam must also participate in an oral exam - presentation.
